The site has several drains running through the site which connect to the drainage network along the southern side of Te Puna Station Road that ultimately discharge to the Wairoa River.

(b) Wetland:

There are no wetlands on the application site. The land has been previous modified through filling the site with approximately 1 to 1.5m of fill to make it suitable for industrial use.

(c) Identified archaeological and proximity to site:

(d) Identified sites of cultural significance and proximity to site:

The mouth of the Wairoa River is known to have urupa which is over one kilometre to the site. Our consultation with Pirirakau has revealed that they are specifically concerned about water quality and stormwater management.

(e) Neighbouring infrastructure: roads, power lines, railway lines:

The application addresses the adjacent road network and also the power supply along the southern side of Te Puna Station Road. The new entrance to the site will require development works approval from WBOPDC.

(f) Protected natural areas or sites of ecological importance:

No sites of ecological importance located on the site.

(g) Ocean/harbour:

The Te Puna Station Road drain flows to a natural stream some 500m to the east of the site which subsequently discharges into the Wairoa River.

- 1 We'll not start processing your application until the \$2700 deposit is paid unless prior arrangement is made. Processing costs are likely to exceed the deposit; we'll invoice you for the balance.
- You may be required to pay a **resource management charge** associated with holding a consent (s36 of the RMA). Accounts are payable by the 20<sup>th</sup> of the month following date of invoice. Where costs are more than \$2000 above the deposit, you may be requested to make interim payments towards the final total cost.

- An assessment of the activity against the relevant objectives and policies in the relevant regional plan/s.
- A record of consultation: names and comments of people you discussed the proposal with.
